<b>Informatie:</b>	<p>Identificatie aandeelhouders, faciliteren stemrecht aandeelhouders, transparantie en promotie van shareholder engagement van institutionele beleggers en asset managers in hun investering.</p> <p>“SRD II establishes requirements in relation to the exercise of certain shareholder rights attached to voting shares in general meetings of companies. This applies where a company has their registered office in a Member State and the shares of which are admitted to trading on a regulated market situated or operating within a Member State.</p> <p>It also establishes specific requirements to encourage shareholder engagement, in particular for the long-term. The requirements apply in relation to the:</p> <ul style="list-style-type: none"> <li>• Identification of shareholders;</li> <li>• Transmission of information;</li> <li>• Facilitation of exercise of shareholders rights;</li> <li>• <b>Transparency of institutional investors;</b> SRD II also requires member states to ensure that institutional investors disclose to the public how their equity investment strategy is aligned with the profile, the duration of their liabilities, and how it contributes to the medium to long-term performance of their assets.</li> <li>• Asset managers and proxy advisors; and</li> <li>• Remuneration of directors and related party transactions.” <a href="#">[Bron]</a></li> </ul> <p>Voor de belangrijkste onderwerpen en de <b>verschillen met SRD I</b>, zie briefing van Clifford Chance: <a href="#">link</a></p>
