




ESG RISICO'S/KANSEN VERSUS (SDG) UITKOMSTEN (OUTCOMES/IMPACT)







What do we define as impact investing?

Impact investments are investments made with the intention to generate positive, measurable social and environmental impact alongside a financial return.

Impact investments can be made in both emerging and developed markets and target a range of returns from below market to market rate, depending on investors' strategic goals.

Why 10%?


- Pension funds leaders in impact investing have **already achieved** (and surpassed) the 10%. -> it is a realistic target







Dutch impact investing market





EUR150-180bn impact investments in NL

Future growth of impact investing

29% of respondents are already 100% invested in impact

58% of respondents will increase the share of AuM in impact

13% will maintain the same level

New players are driving significant growth: a third of new capital flowing in impact investment in 2020 originated from new players

Main barriers

Regulatory barriers, market efficiency hurdles, excessively conservative investment culture

Dutch and European laws and regulations:

- Capital requirements
- High costs of AML/KyC and SFDR implementation

Public management systems:

- Provision of catalytic capital
- Apply an impact lens to all public funds

Main barriers

Regulatory barriers, market efficiency hurdles, excessively conservative investment culture

Lack of information and data sharing:

- Limited marketplace data results in uncertainty and limits capacity building

Limited deals pipeline

Lack of norms and standards

Lack of impact data

Main barriers

Regulatory barriers, market efficiency hurdles, **excessively conservative investment culture**

Short-termism mindset inhibiting market development

- Risk-adverse practices
- Focus on cost

Conventional risk-returns expectations

- Natural and social capital not yet valued

Pension funds main barriers to scale up impact investments?



Strategy/complexity + risk of green/impact washing



IMM (Impact Measurement & Management) + lack of common standards



Deal pipeline / mismatch between demand and offer



Regulations should stimulate rather than complicate



Liquidity / Return


E.g. return: 90% of impact investments achieve their target return

Growth of realized gross returns and assets over time

Over time, impact investments across asset classes in private markets have generated strong realized returns.⁸



Definitie



