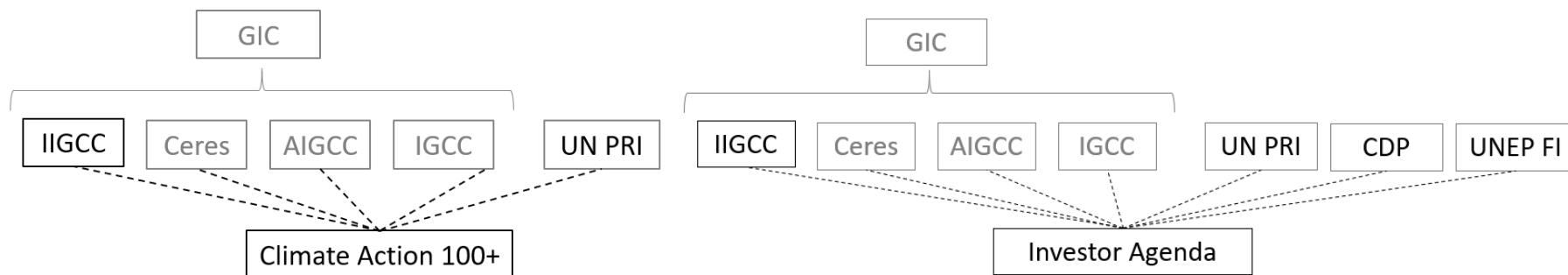

[Climate Action 100+](#) is supported and coordinated by five partner organisations: Asia Investor Group on Climate Change (AIGCC); Ceres; Investor Group on Climate Change (IGCC); Institutional Investors Group on Climate Change (IIGCC); and [Principles for Responsible Investment \(PRI\)](#). It builds upon the collaborative investor engagement pioneered since 2012 by the four organisations (AIGCC, Ceres, IGCC and IIGCC) that together form the **Global Investor Coalition on Climate Change (GIC)**.
