### **Pensioenfonds ABP:**

'Climate change has huge consequences for society and the economy, and thus also for investors. ABP takes the consequences of climate change for the investment portfolio seriously. In this annex, we describe which activities ABP is undertaking to identify and manage climate risks and opportunities. In this report, we follow the framework as developed by the Task Force on Climate-related Financial Disclosures (TCFD).'" [\[Bron\]](#)
