

- 2. Corporate engagement; 'highlights 650 investors with US \$87 trillion in assets backing the <u>CDP</u>'s environmental disclosure request; and 296 investors from 29 countries with US \$31 trillion in assets that are signatories to <u>Climate Action 100+.</u> (...)"
- 3. Investor disclosure; "highlights the more than 60 investors committed to reporting in line with the <u>Task</u> Force on Climate-related Financial Disclosure (TCFD) recommendations. (...)"
